Angus Cameron McPHERSON

Angus Cameron McPherson was born in Sydney, NSW on 17th March, 1886 to parents John & Jeannie McPherson (nee Fulton). His birth was registered in 1886 as Angus C. MacPherson. Angus's parents' marriage was registered in Sydney in 1886 as MacPherson. Angus McPherson had served 3 years with Scottish Rifles.

Angus Cameron McPherson married Olive May Walker on 1st March, 1913 in Sydney, NSW.

A birth was registered in 1913 in the district of Manly, NSW for Angus C. McPherson – parents Angus C. & Olive M. McPherson. Agnes Olive McPherson was born in 1915. Two other children were born – Mary & Ruby McPherson.

Angus Cameron McPherson was a 32 year old, married Motor Driver from Manly, NSW when he enlisted at Manly, NSW on 22nd April, 1918 with the 6th (N) Reinforcements of the Australian Army (A.I.F.). His service number was 54233 & his religion was Presbyterian. His next of kin was listed as his wife – Mrs O. M. McPherson of 8 Pittwater Road, Manly, NSW.

Private Angus Cameron McPherson embarked from Sydney on SS *Field Marshal* on 19th June, 1918. Pte McPherson was appointed Acting Lance Corporal on board on 3rd July, 1918. He was admitted to Ship's Hospital while at Sea from 12th to 14th August, 1918 with Influenza. He disembarked at London, England on 26th August, 1918.

Reinforcements were only given basic training in Australia. Training was completed in training units in England. Some of these were located in the Salisbury Plain & surrounding areas in the county of Wiltshire.

McPherson's rank reverted to Private. He was marched in from Australia to 9th Training Battalion at Fovant, Wiltshire & allotted to Reinforcements of 34th Battalion.

Pte McPherson was transferred to Artillery Details on 4th October, 1918 & marched out to R.B.A.A. (Reserve Brigade Australian Artillery) at Heytesbury, Wiltshire.

Private Angus Cameron McPherson was admitted to the Group Clearing Hospital at Sutton Veny, Wiltshire on 6th October, 1918 with Influenza & Pneumonia. He was transferred to Military Hospital at Sutton Veny, Wiltshire on 9th October seriously ill with Pneumonia.

Private Angus Cameron McPherson died at 08.00 on 11th October, 1918 at the Military Hospital, Sutton Veny of Influenza & Pneumonia.

A death for Angus O. McPherson, aged 32, was registered in the December quarter, 1918 in the district of Warminster, Wiltshire.

Private Angus Cameron McPherson was buried on 14th October, 1918 in St. John the Evangelist Churchyard at Sutton Veny - Grave no. 363. From the burial report of Pte McPherson - *Coffin was good polished Elm with Brass Mounts – Deceased was buried with full Military Honours, the coffin draped with the Union Jack being borne to the graveside on a Gun Carriage preceded by a Firing Party and Band. Six of Deceased's Unit comrades acted as Pallbearers. Two Officers and about seventy N.C.O.'s and Men of the deceased's Unit attended as Mourners. Headquarters A.I.F. Depots in U. K. were represented.*

Pte Angus Cameron McPherson requested in his Will dated 31st May, 1918 that all his real & personal Estate be left to his wife - Olive May McPherson.

Pte Angus Cameron McPherson was entitled to British War Medal only as he had not entered a Theatre of War. A Memorial Scroll & Memorial Plaque were also sent to Pte McPherson's widow – Mrs O. M. McPherson (sent July 1921 & November, 1922).

Private A. C. McPherson is commemorated in the Hall of Memory Commemorative Area at the Australian War Memorial, Canberra, Australia on Panel 124.



Commonwealth War Graves Commission Headstones

The Defence Department, in 1920/21, contacted the next of kin of the deceased World War 1 soldiers to see if they wanted to include a personal inscription on the permanent headstone at St. John the Evangelist Churchyard at Sutton Veny. Space was reserved for 66 letters only (with the space between any two words to be counted as an additional letter) & the rate per letter was around 3 ½ d (subject to fluctuation).

The expense in connection for the erection of permanent headstones over the graves of fallen soldiers was borne by the Australian Government. (Information obtained from letters sent to next of kin in 1921)

A letter from Base Records to Mrs O. M. McPherson of 8 Pitt Water Rd, Manly, dated 26th July, 1921, advised that a communication from the Defence Department concerning an inscription that could be placed on her late husband's Headstone in the Churchyard of Sutton Veny had not yet been replied to. The letter advised that if no reply was received within 21 days, it would be taken as indicating that no further action was required.

Pte Angus Cameron McPherson does have a personal inscription on his headstone.
