# **Charles Horace PITTARD**

Charles Horace Pittard was born at Gawler, South Australia on 7<sup>th</sup> April, 1883 to parents Edwin John & Elizabeth Pittard (nee Stone).

The 1910 Australian Electoral Roll for the division of Kalgoorlie, Western Australia listed Charles Horace Pittard, brewery hand, living at 337 Hannah Street. Also listed at the same address was Archibald Pittard, labourer.

Charles Horace Pittard married Mary Williams on Perth, Western Australia in 1911.

The 1916 Australian Electoral Roll for the division of Perth, subdivision of North Perth listed Charles Horace Pittard, brewery hand, living at 8 Robinson Avenue. No other Pittards were listed at that address.

Charles Horace Pittard was a 29 year old, married, Brewery Hand from Perth, Western Australia when he enlisted at Pert, Western Australia on 14<sup>th</sup> June, 1916 with the 11<sup>th</sup> Infantry Battalion, 21<sup>st</sup> Reinforcements of the Australian Army (A.I.F.). His service number was 6557 & his religion was Baptist. His next of kin was listed as his wife – Mrs Mary Pittard of Coogee Street, Mount Hawthorn, Western Australia.

Private Charles Horace Pittard embarked from Fremantle on HMAT *Suffolk (A23)* on 10<sup>th</sup> October, 1916 & disembarked at Plymouth, England on 2<sup>nd</sup> December, 1916.

Reinforcements were only given basic training in Australia. Training was completed in training units in England. Some of these were located in the Salisbury Plain & surrounding areas in the county of Wiltshire.

Pte Pittard was marched in to from Australia to 8<sup>th</sup> Training Battalion on 2<sup>nd</sup> December, 1919 then transferred to 3<sup>rd</sup> Training Battalion at Durrington, Wiltshire on 17<sup>th</sup> December, 1916.

Pte Pittard was admitted to Fargo Military Hospital on 19<sup>th</sup> January, 1917 with an abdominal tumor (severe) & discharged on 22<sup>nd</sup> January, 1917.

Pte Pittard was written up for being absent without leave from 9 am on 16<sup>th</sup> April, 1917 till reporting back at 9 pm on 22<sup>nd</sup> April, 1917. He was awarded 168 hours detention & forfeited 14 days' pay.

Pte Pittard proceeded overseas from 3<sup>rd</sup> Training Battalion at Durrington via Folkestone on 3<sup>rd</sup> May, 1917.

Pte Pittard joined Base Depot at Etaples, France on 4<sup>th</sup> May, 1917. He joined his Battalion in France on 4<sup>th</sup> June, 1917.

Pte Pittard was sent to 3<sup>rd</sup> Field Ambulance with Influenza on 24<sup>th</sup> June, 1917. He was transferred to 56<sup>th</sup> Casualty Clearing Station on 6<sup>th</sup> July, 1917 & admitted to 1<sup>st</sup> Australian General Hospital on 9<sup>th</sup> July, 1917. Pte Pittard was transferred to Con. Depot at Rouen on 14<sup>th</sup> July, 1917 then transferred to 11 Con. Depot at Buchy on 19<sup>th</sup> July, 1917.

Pte Pittard was marched in to 1<sup>st</sup> A.D.B.D. (Australian Divisional Base Depot) on 12<sup>th</sup> August, 1917. He proceeded to join his Unit at Havre on 29<sup>th</sup> August, 1917 & rejoined his Battalion on 31<sup>st</sup> August, 1917.

Pte Pittard was sent to Hospital in Belgium on 13<sup>th</sup> November, 1917 & admitted to 10 Sty. at St. Omer on 14<sup>th</sup> November, 1917. He was transferred to 7<sup>th</sup> C.D. on 21<sup>st</sup> November, 1917. Pte Pittard was transferred to 3<sup>rd</sup> Rest Camp at St. Omer on 28<sup>th</sup> November, 1917.

Pte Pittard was transferred to Base Depot at Havre on 3<sup>rd</sup> December, 1917 & proceeded to join his Unit on 6<sup>th</sup> December, 1917. Pte Pittard rejoined his Unit on 10<sup>th</sup> December, 1917.

Pte Pittard was on leave to U.K. on 14<sup>th</sup> February, 1918 & rejoined his Battalion form leave on 9<sup>th</sup> March, 1918.

Pte Pittard was sent sick to Hospital – 3<sup>rd</sup> Australian Field Ambulance on 4<sup>th</sup> May, 1918. He was admitted to 54<sup>th</sup> General Hospital on 7<sup>th</sup> May, 1918 with Whitlow finger (slight). Pte Pittard was transferred to England on Hospital Ship *Jan Breydal* on 8<sup>th</sup> May, 1918. He was admitted to County of Middlesex War Hospital Napsbury St. Albans on 8<sup>th</sup> May, 1918. Pte Pittard was then transferred to 3<sup>rd</sup> Auxiliary Hospital at Dartford on 21<sup>st</sup> May, 1918. Pte Pittard was discharged to No. 3 Command Depot at Hurdcott, Wiltshire on 24<sup>th</sup> June, 1918.

Pte Pittard was absent without leave from midnight on 1<sup>st</sup> August, 1918 until 10.45 am on 4<sup>th</sup> August, 1918. He forfeited a total of 8 days' pay.

Pte Pittard was marched out to No. 1 Command Depot on 6<sup>th</sup> September, 1918.

Pte Pittard was absent without leave from 0900 hrs on 5<sup>th</sup> December, 1918 until 1600 hrs on 11<sup>th</sup> December, 1918. He was awarded 20 days Field Punishment (No. 2) & forfeited a total of 27 days' pay.

Pte Pittard was absent without leave from Sutton Veny from 14<sup>th</sup> January, 1919 & returned on 7<sup>th</sup> February, 1919.

Pte Pittard was again absent without leave from 7<sup>th</sup> February, 1919 until 1545 hrs on 22<sup>nd</sup> February, 1919. He was awarded 16 days Field Punishment No. 2 & a total forfeiture of 32 days' pay on 3<sup>rd</sup> March, 1919.

Private Charles Horace Pittard was sent sick to Hospital on 24<sup>th</sup> March, 1919 & admitted to the 1<sup>st</sup> Australian General Hospital at Sutton Veny, Wiltshire with an Intestinal obstruction.

Private Charles Horace Pittard died at 7.30 p.m. on 24th March, 1919 at the 1<sup>st</sup> Australian General Hospital, Sutton Veny of an Intestinal obstruction.

A death for Charles H. Pittard, aged 31, was registered in the March quarter, 1919 in the district of Warminster, Wiltshire.

Mrs Mary Pittard had written a letter dated 23<sup>rd</sup> March, 1920 enquiring into how long her husband was ill before he died. The Red Cross Wounded and Missing file for Pte Charles Horace Pittard contains a letter from Registrar for Officer Commanding 1<sup>st</sup> Australian General Hospital, Sutton Veny which reads:

"The above mentioned soldier was admitted to this Hospital on the 24<sup>th</sup> March from No. 1 Command Depot. During the evening of the same day he died from Intestinal Obstruction."

Private Charles Horace Pittard was buried on 27<sup>th</sup> March, 1919 in St. John the Evangelist Churchyard at Sutton Veny - Grave no. 78. From the burial report of Pte Pittard - Coffin was Elm with Brass Mounts – Deceased was buried with full Military Honours, the coffin draped with the Australian flag being conveyed to the graveside on a Gun Carriage preceded by a Firing Party and Band from 1<sup>st</sup> Australian Training Brigade Sutton Veny. Six Australians supported the Pall. The "Last Post" was sounded and volleys fired over the grave. A number of Australians followed the remains and were present at the graveside ceremony. Headquarters A.I.F. Depots in United Kingdom were represented at the funeral.

Private C. H. Pittard is commemorated in the Hall of Memory Commemorative Area at the Australian War Memorial, Canberra, Australia on Panel 63.

Pte Charles Horace Pittard was entitled to British War Medal & the Victory Medal. A Memorial Scroll & Memorial Plaque were also sent to Pte Pittard's widow – Mrs M. Pittard (Scroll sent December, 1921 & Plaque sent November, 1922).

The CWGC lists Private Charles Horace Pittard, 6557, of 11th Battalion, Australian Infantry, A.I.F., as the son of Elizabeth and the late Edwin Pittard; husband of Mary Pittard, of 97 Coogee St, Mount Hawthorn. Born in South Australia.

PITTARD - Died on service with the A.I.F., Ist Australian General Hospital, Charles Horace, beloved brother of George and Maud, 34 Coronation-street, North Perth.

PITTARD - Died from illness, March 24, 1919 while on active service, Private C. H. Pittard, son-in-law of Mrs. M. Williams, Mount Hawthorn; brother-in-law of Mr and Mrs H. Williams and Mr and Mrs S. Allen.

#### Commonwealth War Graves Commission Headstones

The Defence Department, in 1920/21, contacted the next of kin of the deceased World War 1 soldiers to see if they wanted to include a personal inscription on the permanent headstone at St. John the Evangelist Churchyard at Sutton Veny. Space was reserved for 66 letters only (with the space between any two words to be counted as an additional letter) & the rate per letter was around 3 ½ d (subject to fluctuation).

The expense in connection for the erection of permanent headstones over the graves of fallen soldiers was borne by the Australian Government.
